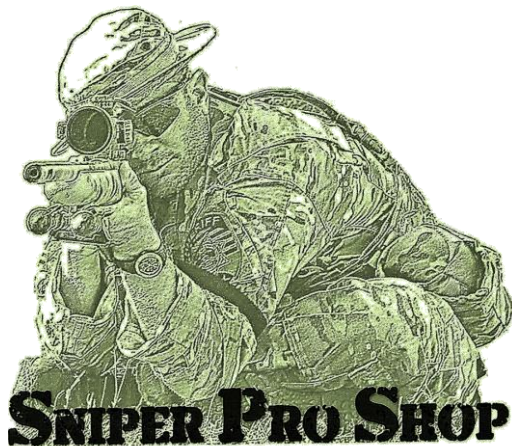

***The Sniper Pro Shop / High Ground Training Group will provide a Level III Sniper – Leadership, Training and Utilization of SWAT Snipers Course in Chattanooga, TN, 5 – 7 November 2025. The Level III Sniper Course is geared toward command-and-control staff that will be tasked with developing, overseeing and leading SWAT snipers. The course revolves around the SPS Sniper Section Standards and will introduce non-sniper trained command staff to the necessary skills and proper training for their snipers. For existing law enforcement snipers who are assigned as Sniper Section leaders, the course covers training, scheduling and tactical deployment and field management of teams as well as policy issues and effective communication with SWAT command staff.***

***Target Audience: SWAT Commanders, SWAT Team Leaders, Sniper Section Leaders, Agency Administrators, Snipers requiring continuing education.***



### COURSE DESCRIPTION

*The SPS/HGTG Level III Sniper Course is designed for those who lead and command snipers and who must make informed decisions in the field. The course deals with a sniper's role within special operations, selecting and training sniper candidates, using snipers most effectively in a critical incident as well as in reconnaissance roles and overwatch details, and addresses policy, practice and operational concepts. The course culminates in a live-fire shooting event where snipers, team leaders and commanders shoot together in a live-fire demonstration. Snipers attending the course may bring their issued weapon system and participate in live-fire demonstrations and sample training and qualification drills. Team Leaders & Commanders are encouraged to participate in the live fire event.*

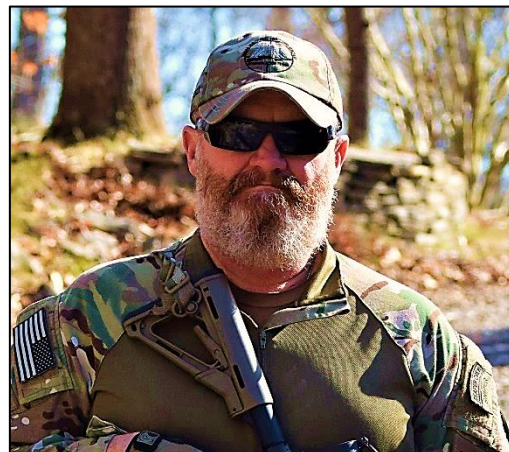
